My name is Nicole Nathan and I am a Research Fellow at The University of Newcastle, Australia and Program Manager with Hunter New England Population Health.



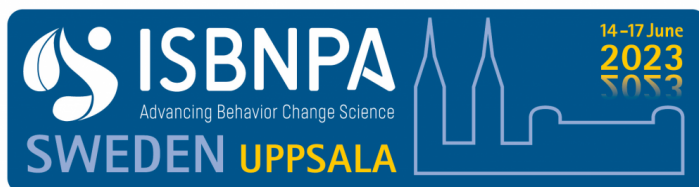

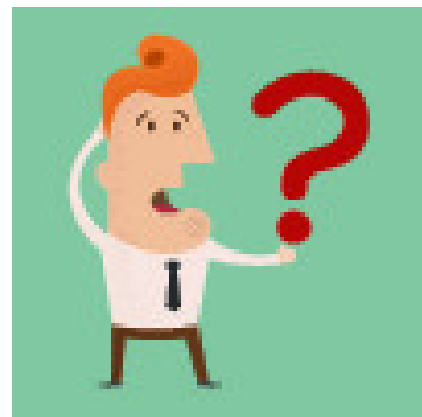
